### **VERSION OF 03/10/2023**

**(2)** For purchases made after 18/07/2023, the battery is guaranteed for 5 years.

During the warranty period, CROSSCALL will replace the defective battery if the following 2 cumulative conditions are met:

- Battery capacity less than or equal to 70%
- Number of full charge cycles less than or equal to 850

**(3)** Except protective screen covers like the X-GLASS and protective films, X-BLOCKER and SIM card adapters, which are not covered by this guarantee.

**(4)** Spare parts are available for as long as the new product is on the market and for a period of 10 years from the date on which the last unit of the model concerned was put to market.

For the CORE M4, the market's release date of the last unit of the new product is 03/11/2021, spare parts are available until 02/11/2031.

For the CORE-M4 GO, the market's release date of the last unit of the new product is 03/11/2021, spare parts are available until 02/11/2031.

For the CORE-X4, the market's release date of the last unit of the new product is 24/02/2022, spare parts are available until 23/02/2032.

For the CORE- S4, the market's release date of the last unit of the new product is 23/06/2022, spare parts are available until 22/06/2032.

**(5)** Spare parts are available for 2 years from the product's market release date.

For the ACTION-X3, the date the new product was put to market is 23/11/2017, spare parts are available until 22/11/2019.

For the CORE-X3, the date the new product was put to market is 13/09/2018, the spare parts are available until 12/09/2020.

For the TREKKER-X4, the date the new product was put to market is 24/10/2018, spare parts are available until 23/10/2020.

For the CORE-T4, the date the new product was put to market is 10/02/2020, spare parts are available until 09/02/2022.
